Rental Agreement and Liability Waiver

It is the responsibility of the person or organization hiring this inflatable equipment to ensure that all possible precautions are taken to avoid injury to people or damage to the Inflatable. Please ensure that the following Safety Instructions are followed:

1. No food, drink or chewing gum on or around the Inflatable. This will avoid a choking risk and keep the unit clean. (Please note if the Inflatable is collected in a dirty condition, then the person hiring it will incur a cleaning charge)
2. Shoes, glasses, jewelry, and badges MUST be removed before using the inflatable to avoid injury to people using the equipment and harm to the Inflatable.
3. No face paints, party poppers, colored streamers, or silly string to be used either on or near the Inflatable. (Please note these products will cause damage to the Inflatable that cannot be repaired)
4. NO smoking on or around the Inflatable.
5. NO barbeques around the Inflatable.
6. Climbing, hanging, or sitting on walls is dangerous and must not be allowed. NO user is ever to slide head first down the slide of the inflatable unit. Always make sure slide is clear of others before sliding and never stand up on slide platform.
7. A responsible Adult must supervise the inflatable at all times.
8. Always ensure that the Inflatable is not overcrowded, and limit numbers according to the age and size of Children using it. Try to avoid large and small children from using it at the same time.
9. Ensure Children are not pushing, colliding, fighting, or behaving in a manner likely to injure or cause distress to others.
10. No pets, toys, or sharp instruments on the inflatable at any time.
11. Do not allow anyone to bounce on the front safety step as this is dangerous.
12. Do not allow anyone to be on the inflatable equipment during inflation or deflation as this is DANGEROUS.
13. Please ensure that Children are not attempting somersaults and are clothed appropriately and that nothing can fall out of their pockets.
14. The inflatable unit has an age limit of 13 years. (Unless otherwise stated in the inflatable unit description). Please ensure that no one over this age uses any part of the inflatable unit, especially adults. All riders must be over 2 years old. Due to safety, manufacturing, and insurance liabilities, it is imperative that the renters do not exceed the recommended child capacity.
15. It is advisable to ensure that no one with any history of back, neck problems or any other disability use the inflatable unit. Absolutely no pregnant women and any other persons susceptible to injury from falls, bumps and bouncing are not permitted in or on the inflatable unit at any time.
16. In the event that the blower stops working, please ensure all users get off the inflatable immediately and calmly. Check your breaker(s) and make sure the blower tube or deflation tube has not come undone or something has not blown onto and is obstructing the blower. In the event that it overheats, or loses power, switch the blower off at the mains, then switch it back on again 1 or 2 minutes later, and it should restart. If it does not, inform us immediately at (647)-498-4096.
17. In the event of rain, the inflatable unit must be deflated. Using the inflatable unit in the rain is unsafe and NOT permitted. The blower MUST be stored in a dry place during rainstorms. Failure to unplug the blower during a rainstorm could possibly result in electric shock by participants. The inflatable unit will become VERY slippery during rainstorms and is NOT safe for jumping or playing on. Failure to follow these rules could result in serious injury. When safe to re-use switch back on and towel dry any remaining wetness before allowing children back on. (Please note bubbling is normal).
18. THE MOST IMPORTANT RULE: DO NOT let children play on the inflatable without adult supervision. Adult supervision is necessary to enforce these rules for safe operation of the Inflatable.

LIABILITY DISCLAIMER

1. This rental equipment has been received in good condition and will be returned in the same condition (ordinary wear and tear accepted).
2. Customer assumes all responsibility for injuries to persons or damages to property and agrees to release and hold The Kangaroo's Castles harmless for any and all claims, of whatsoever nature, arising out of use of the rental equipment while in his/her custody. In the event that the release and hold harmless as contained herein is held unenforceable for any reason, customer hereby agrees to a limit on any damages claimed by customer to the total paid to The Kangaroo's Castles for the rental.
3. Customer agrees to company right to enter premises of customer at any time to repossess said equipment.
4. Customer agrees to reimburse The Kangaroo's Castles for all attorney fees, an amount not less than 50% of all sums due, court cost and expenses incurred by The Kangaroo's Castles to enforce collection or to preserve or enforce rights under this contract.
5. Customer agrees not to loan, sublet, or otherwise dispose of equipment or use it at any other location.
6. Customer agrees to pay in full the replacement cost, including labor, for all damages to rental equipment.
7. If the inflatable equipment is lost, stolen, or damaged beyond repair the renter agrees to pay the value of the inflatable rented.
8. Customer agrees to ensure that all users (and users' guardians) of the rental equipment sign liability waivers.
9. THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS EITHER EXPRESSED OR IMPLIED.
